## Calculus Review/Assignment 1

## Slope



Slope is defined as the rise over the run: Slope $=$ rise/run. The rise is the change in the $y$ value and the run is the change in the x value.

Slope $=$ rise $/$ run $=\Delta y / \Delta x=\left(y_{2}-y_{1}\right) /\left(x_{2}-x_{1}\right)$
Note that the result is the same if the subscripts identifying the points are reversed; for this case, numerator and denominator will both be negative and the negatives cancel. It is critical that the ordered pairs are kept separate however.

It also does not matter what quadrant the points lie in; the signs work out correctly.
The slope is closely related to the concept of a derivative in Calculus. In the simplest terms, the derivative is the slope at a point on a curve, which is the same as the slope of the tangent to the curve. Standard Leibniz notation for the derivative is based on $\Delta y / \Delta x$; the derivative is written $d y / d x$.

## Exponent Definition

$x^{0}=1$

## Derivative of a Line

Recall the equation for a straight line: $y=a x+b$. The slope is $a$ and the $y$ axis intercept is $b$.

The derivative of a function of the form $y=a x^{n}+b$ with respect to $x$ is
$d y / d x=a n x^{(n-1)}$.
(Because $b$ is a constant [think of it as $b x^{0}$ ] its derivative is $0 b x^{-1}=0$, and it drops out of the overall derivative.)

For a straight line, $n=1$ so
$d y / d x=a 1 x^{(0)}$, or because $x^{0}=1$, $d y / d x=a$.

## Derivative of a Polynomial

In differential Calculus, we consider the slopes of curves rather than straight lines.
For a general polynomial $y=a x^{n}+b x^{p}+c x^{q}+\ldots$, the derivative with respect to x is
$d y / d x=a n x^{(n-1)}+b p x^{(p-1)}+c q x^{(q-1)}+\ldots$
Here is an example with the following coefficients and exponents:

| a | 3 |
| :--- | :--- |
| n | 3 |
| b | 5 |
| p | 2 |
| c | 5 |
| q | 0 |



Note that the slope of this function, instead of being a constant, is itself a function of x . In this case, for $x$ less than 0 the slope is negative and, for $x>0$, the slope is positive. The sign and magnitude of the slope are given by the derivative.


## Derivative of Sine and Cosine

You will also need to know the derivative of the sine and cosine functions for this class. First, always remember that $\sin (0)=0$ and that the period of both the sine and cosine functions is $2 \pi$. Now look at the sine function and notice that its initial slope is positive and that it becomes negative at $\pi / 2$. This is exactly the behavior of the cosine and in fact $d(\sin (x)) / d x=\cos (x)$. You can also see that the initial slope of the cosine is negative so you can figure out that $d(\cos (x)) / d x=-\sin (x)$.


## Partial Derivatives

What if the variable of interest - say water table elevation - is a function of both $x$ and $y$ ? In this case we use the concept of a partial derivative.

Here is a plot of the function $h(x, y)=x^{4}+y^{3}+x y$. To compute the partial derivative of $h$ with respect to $x$ at a $y$ location $y_{0}$ (indicated by the notation $\partial h /\left.\partial x\right|_{y=y 0}$ ), we simply treat any terms containing $y$ only as constants. If these constants stand alone (like $b$ in the computation of the derivative of the straight line) they drop out of the result. If they are in multiplicative terms involving $x$, they are retained as constants. Thus $\partial \mathrm{h} / \partial \mathrm{x} \mid \mathrm{y}=\mathrm{y} 0=4 \mathrm{x}^{3}+$ yo.


So what use are these partial derivatives?
One simple and important application is for the computation of gradients. The gradient function of $h(x, y)$ can be written as

Vh or Grad $h$ or ('del')h (bold means vector)

$$
\begin{equation*}
\nabla \boldsymbol{h}=\mathbf{i} \frac{\partial \boldsymbol{h}}{\partial x}+\mathbf{j} \frac{\partial \boldsymbol{h}}{\partial y} \tag{1}
\end{equation*}
$$

$\mathbf{i}$ and $\mathbf{j}$ are the unit vectors in the $x$ and $y$ directions; that is they point in the positive x and $y$ directions respectively and have length 1 . The vector sum of these vectors multiplied by their respective partial derivatives gives the gradient vector.

## Numerical Derivatives

Numerical approximations of derivatives can be made by taking the slope between points and can serve as a useful check on the analytical derivative. Very often, there is no analytical derivative and all computations must rely on numerical derivatives. There are obvious limitations to this approach. Grid spacing and position of the computed derivative need to be considered.

Next, we'll demonstrate the computation of numerical partial derivatives using MATLAB. Let's use a realistic ground water potential surface (i.e., a solution of the Laplace equation that we will derive later).

In MATLAB,
$\mathrm{h}=[]$;
[dhdx,dhdy]=gradient(h)
contour([1:20],[1:20],h)
hold
quiver([1:20],[1:20],-dhdx,-dhdy)


The length and direction of the arrows indicate the strength and direction of the gradient. As you will see, partial derivatives also play a key role in ground water flow models.

Another useful way to look at such a field is known as 'streamlines', which trace the trajectory of a particle released at a given point in the domain. MATLAB provides algorithms that make the necessary calculations and display the graphics.
[Stream]= stream2(-dhdx,-dhdy,[51:100],50*ones(50,1)); streamline(Stream)
(This is for stream lines starting at $\mathrm{y}=50$ from $\mathrm{x}=51$ to 100 along the x axis. Different geometries will require different starting points.)

## Assignment

1. (5 points) You are given the following ordered pairs: Line $1:(1,1),(3,2)$, Line 2 : $(1,-1)$, (3,-2); Line 3: $(-1,-1)$, ( $-3,-2$ ) ; Line 4: $(-1,1),(-3,2)$. Plot the points, compute the slopes.
2. (5 points) You are given the following ordered pairs: Line 1: (1,1), (-3,-2); Line 2: $(1,-1),(-3,2)$; Line 3: $(-1,-1),(1,-1)$; Line $4:(-1,1),(-1,-1)$. Plot the points, compute the slopes.
3. (10 points) Write down the partial derivative $\partial h /\left.\partial x\right|_{y=-1}$ of $h(x, y)=x^{3}+y^{2}+x y$. Plot the whole function. Then plot $h(x,-1)$ and the partial derivative between $\mathrm{x}=-$ 1 and 1 on the same graph. Add the numerical approximation of the derivative to the same graph. Use solid lines for the analytical function and derivative and points for the numerical derivative. Discuss limitations of this numerical derivative.
4. (10 points) Write down the partial derivative $\partial h /\left.\partial x\right|_{y=1}$ of $h(x, y)=x^{3}+y^{2}+x y$. Plot the function, $h(x, 1)$, and the partial derivative between $x=-1$ and 1 . Plot the numerical approximation of the derivative on the same graph. Use solid lines for the analytical function and derivative and points for the numerical derivative.
5. (10 points) Write down the partial derivative $\partial h /\left.\partial y\right|_{x=-1}$ of $h(x, y)=x^{3}+y^{2}+x y$. Plot the function, $h(1, y)$, and the partial derivative between $y=-1$ and 1 . Plot the numerical approximation of the derivative on the same graph. Use solid lines for the analytical function and derivative and points for the numerical derivative.
6. (10 points) Write down the partial derivative $\partial h /\left.\partial x\right|_{y=-1}$ of $h(x, y)=x^{3}+y^{2}+x^{2} y$. Plot the function, $h(x,-1)$, and the partial derivative between $x=-1$ and 1 . Plot the numerical approximation of the derivative on the same graph. Use solid lines for the analytical function and derivative and points for the numerical derivative.
7. (10 points) Write down the partial derivative $\partial h /\left.\partial x\right|_{y=1}$ of $h(x, y)=x^{3}+y^{2}+x^{2} y$. Plot the function, $h(x, 1)$, and the partial derivative between $x=-1$ and 1 . Plot the numerical approximation of the derivative on the same graph. 8. (10 points) Write down the partial derivative $\partial h /\left.\partial y\right|_{x=-1}$ of $h(x, y)=x^{3}+y^{2}+x^{2} y$. Plot the function, $h(1, y)$, and the partial derivative between $y=-1$ and 1 . Plot the numerical approximation of the derivative on the same graph. Use solid lines for the analytical function and derivative and points for the numerical derivative.
9. (15 points) Show that $h(x, y)=x^{2}-y^{2}+x y$ is a solution of the 2-D Laplace Equation [Eqn. (2)]. Plot and label contours of the function and plot arrows indicating the strength and direction of the negative gradient using MATLAB or Python. Mark the 'stagnation point'.
10. (15 points) Instead of arrows as in Question 9, plot streamlines using MATLAB or Python.
